**BEA Signs Memorandum of Understanding with Anchorpoint to Explore
Real-World HKD-backed Stablecoin Applications**

*Joint efforts with complementary strengths to expand digital asset capabilities
and advance Hong Kong's innovation roadmap*

Hong Kong, 28 August 2026 – The Bank of East Asia, Limited (“BEA”) and Anchorpoint Financial Limited (“Anchorpoint”), a Hong Kong-licensed stablecoin issuer, today jointly announced the signing of a Memorandum of Understanding (“MoU”) to establish a partnership that positions BEA among the first batch of banks to partner with Anchorpoint to explore digital asset initiatives enabled by HKDAP, the regulated HKD-backed stablecoin.

This partnership brings together Anchorpoint’s rigorous, regulated stablecoin issuance capabilities with BEA’s established banking services. As part of the MoU, BEA will collaborate with Anchorpoint to explore real-world use cases for HKD-backed stablecoins supporting secure and compliant financial solutions to customers.

Mr Zinnser Hong, Group Chief Innovation Officer, General Manager and Head of Innovation Office of BEA, said, “This partnership with Anchorpoint marks a major milestone in accelerating the Bank’s digital transformation. Blockchain technology and tokenisation are key to addressing unique demands of borderless, 24/7 digital finance. As we continue to drive innovation and build on our extensive network and comprehensive banking services, this collaboration represents a significant step forward in building Hong Kong’s digital asset leadership.”

Mr Dominic Maffei, Chief Executive Officer and Co-Founder, Anchorpoint, said: “The value of regulated tokenised money lies in its ability to support real economic activity and deliver tangible benefits to business and market participants. With BEA’s strong banking capabilities and extensive client network, we look forward to working together to develop new commercial applications for HKDAP and bring regulated tokenised money into practical payment and settlement use cases.”

Further details regarding the HKDAP partnership and arrangement will be announced in due course.
